[BRIEF RECORD OF PROCEEDINGS]

1. **QUESTIONS** 10.30 A.M.

Thirty two Starred Questions (Q. Nos. 133, 172 & 211 to 240) were put down on the order paper. One question (Q. No.227) was deleted having been transferred to 20.07.2010 for reply by the Minister for Panchayati Raj. Three questions (Q. No. 212, 214 & 217) were discussed with supplementaries. Answer to 28 Starred Questions were laid on the Table.

One hundred and eight three Un-starred questions (Q. No.680, 1082 to 1263) were put down on the order paper. Five questions (Q.
