**[BRIEF RECORD OF PROCEEDINGS]**

**1. QUESTIONS**

10.30 A.M.

Thirty one Starred Questions (Q. Nos. 258, 301 to 330) were put down on the order paper. One question (Q. No.329) was deleted having been transferred to 23.7.2010 for reply by the Minister for Transport. Seven questions (Q.No.258, 301, 305, 307, 308, 309, 311) were discussed with supplementaries. Answer to 23 Starred Questions were laid on the Table.

Two hundred and forty six Un-starred questions (Q. No. 1597 to 1842) were put down on the order paper.
