[BRIEF RECORD OF PROCEEDINGS]

1. QUESTIONS

10.30 A.M.

Thirty three Starred Questions (Q. Nos. 99, 227, 256 and 331 to 360) were put down on the order paper. Six questions (Q.No.256, 331, 333, 334, 335 and 337) were discussed with supplementaries. Answer to 27 Starred Questions were laid on the Table.

Two hundred and forty Un-starred questions (Q. No. 815, 819, 824, 1084, 1120, 1150 and 1843 to 2076) were put down on the order paper.
