[BRIEF RECORD OF PROCEEDINGS]

1. QUESTIONS 10.30 A.M.

Thirty one starred questions (Q. No.5, 61 to 90) were put down on the order paper. One question (Q. No.63) was deleted having been transferred to 27.11.2007 for reply by the Minister for Steel & Mines. Answer to thirty starred questions were laid on the Table.

One hundred and seventy eight un-starred questions (Q. No. 170, 358 to 534) were put down on the order paper. Sixteen un-starred questions (Q. No. 377, 484, 408, 514, 386, 399, 434, 472, 477, 392, 424, 518, 441, 443, 475, 515) were deleted having been transferred to 27.11.07, 26.11.07 and 01.12.07 for reply by the Minister for Revenue & Disaster Management, Chief Minister, Minister for Steel & Mines, Minister for Energy, Minister for Planning and Co-ordination and Minister for Textile and Handlooms. Answer to 251 un-starred questions were laid on the Table. Materials were not ready with regard to Q. No. 362, 398, 421, 445, 450, 451, 452, 462, 486 and 511.
