**[BRIEF RECORD OF PROCEEDINGS]**

1. QUESTIONS 10.30 A.M.
- Thirty Starred Questions (Q. Nos. 91 to 120) were put down on the order paper. One question (Q. No.99) was deleted having been transferred to 20.7.2010 for answer by the Minister for Fisheries and Animal Resources Development. Four questions (Q.No.91, 92, 93 & 95) were discussed with supplementaries. Answer to 25 Starred Questions were laid on the Table.
- One hundred and fifty Un-starred questions (Q. No. 461 to 610) were put down on the order paper. Three questions (Q.No.514, 562, 594) were deleted having been transferred to 14.7.2010, 28.6.2010, 26.6.2010 for reply by the Minister for Rural Development, Chief Minister and Minister for Labour & Employment. Answer to 141 Un-starred questions were laid on the Table. Materials were not ready with regard to Q. No.465, 471, 494, 518, 574 and 602.
