**[BRIEF RECORD OF PROCEEDINGS]**

**1. QUESTIONS**

**10.30 A.M.**

Thirty Starred Questions (Q. Nos.481 to 510) were put down on the order paper. Three questions (Q No.494, 495 & 503) were deleted having been transferred to 29.7.2010, 30.7.2010 & 04.08.2010 for reply by the Minister for Public Enterprises, Urban Development & Steel & Mines. Five questions (Q.No.483, 486, 489, 492 & 493) were discussed with supplementaries. Answer to 22 Starred Questions were laid on the Table.

One hundred forty Un-starred questions (Q. No.2097, 2147, 2176, 2225, 2235, 2501 & 2653 to 2786) were put down on the order paper. Six questions (Q.No.2678, 2679, 2716, 2720, 2772 & 2783) were deleted having been transferred to 27.7.2010, 28.7.2010 and 30.7.2010 for reply by the Minister for Agriculture, Minister for Panchayati Raj, Minister for Revenue & Disaster Management & Minister for Urban Development.
