[BRIEF RECORD OF PROCEEDINGS]

1. QUESTIONS

10.30 A.M.

Thirty two Starred Questions (Q. Nos.288, 435 and from 541 to 570) were put down on the order paper. Five questions (Q.No.546, 547, 550, 551 & 552) were discussed with supplementaries. Answer to 27 Starred Questions were laid on the Table.

One hundred sixteen Un-starred questions (Q. No.2355, 2678, 2679, 2710 and from 2951 to 3062) were put down on the order paper. Three questions (Q.No.2985, 3050 & 3057) were deleted having been transferred to 02.8.2010 for reply by the Chief Minister. Answer to 95 Un-starred questions were laid on the Table. Materials were not ready with regard to Q No.2679, 2951, 2952, 2975, 2987, 2988, 2997, 3009, 3010, 3012, 3016, 3024, 3026, 3034, 3044, 3052, 3058 & 3062.

2. APPEAL OF HON'BLE SPEAKER
