**[BRIEF RECORD OF PROCEEDINGS]**

**1. QUESTIONS:**

After reply, the amendment moved by Shri Ranendra Pratap Swain (a) (i) and (ii) of the regulation - 12 of the Orissa Electricity Regulatory Commission (Terms and Conditions for open Access) Regulation, 2005 as accepted by the Minister was adopted.
