The E.M.D. furnished by the highest tenderer will be adjusted against the sale price of the vehicles.

The Sealed Tenders should reach the Joint Secretary (V&T), Odisha Legislative Assembly by 31.1.2012 up to 1.00 P.M. at the latest and tenders so received shall be opened by the Joint Secretary (V&T), Odisha Legislative Assembly on the same day i.e. on 31.1.2012 at 3.30 P.M. in his Office Chamber in the presence of the tenderers or their authorised agents. If the 31st January, 2012 is declared as a Government holiday then the tenders will be received and opened on the next working day as per the scheduled time. The tenderers shall produce their identity proof at the scheduled time before opening of tenders.

The highest tenderer whose tender would be accepted shall deposit immediately 25% of the offered amount as initial deposit. He shall deposit the balance amount within seven days of the deposit of the initial amount and remove the vehicle with permission of the Joint Secretary (V&T), Odisha Legislative Assembly. In case, he fails to make the deposit of the total amount as per the tender within the stipulated time, his deposit including the earnest money shall be forfeited. VAT as admissible shall be levied on the bidding cost.

In case the tenderer whose tender would be accepted fails to remove the vehicle from Odisha Legislative Assembly Premises within the stipulated time he shall pay

ground rent at the rate of 1% of his quoted price per day. If the ground rent so charged exceeds the amount deposited by the highest tenderer on the date of opening of tender then the tenderer shall cease to have any right on the vehicle and the amount deposited by him shall be adjusted towards ground rent.




